العربية، بما فيها القراران ٢٤٢ و ٣٣٨، تشترك منظمة التحرير الفلسطينية في المؤتمر الدولي للسلام باعتبارها الممثل الوحيد للشعب الفلسطيني، والمعترف بها، عربياً ودولياً، ولها صفة عضو مراقب في هيئة الامم، منذ العام ١٩٧٤.

وان مشاركة منظمة التحرير الفلسطينية في المؤتمر الدولي يكون على اساس ضمان الحقوق المشروعة الشعب الفلسطيني، بما فيها حقه في تقرير المصير من خلال اتحاد كونفدرالي مع المملكة الأردنية الهاشمية المنصوص عليه في الاتفاق الأردني ـ الفلسطيني الموقع في شباط (فبراير) ١٩٨٥.

وتؤكد المنظمة، في هذا المجالِّ، شجبها، ورفَّضها، للأرهاب الذِّي اكدته، مجدداً، في اعلان القاهرة.

- (أ) يُسلّم هذا المشروع لجلالة الملك.
- (ب) ترجو المنظمة من جلالة الملك الحصول على التزام خطي من الولايات المتحدة [الاميكية] بدعم حق تقرير المصيركما نص عليه الاتفاق الأردني -الفلسطيني،
- (ج) يتزامن اعلان المنظمة موافقتها المشروطة على القرار ٢٤٢ مع اعلان حكومة الولايات المتحدة [الاميركية] بقبولها باقرار حق تقرير المصير للشعب الفلسطيني.

Third Proposal

The invitation to convene an international Conference to resolve the conflict in the Middle East and to solve the Palestinian Question should be under the aegis of the United Nations, because it is the International Organization which was established after World War II to put an end to the sufferings of the peoples, prevent agression and maintain justice and respect for human rights.

The preamble of the United Nations' Charter adopted in 1945 calls for the realization of international cooperation, the resolution of international problems, realization of basic human rights and the rights of the peoples to self-determination.

Since the Palestinian Question is the quintessence of the Middle East problem, the call to convene an international conference to resolve the conflict should be to ensure the execution of resolutions and measures and should include the participation in the conference of the permanent members of the Security Council, and be attended by all the concerned Arab parties including the Palestine Liberation Organization on an equal footing within a joint Jordanian - Palestinian delgation.

In accordance with the United Nations' Charter which reaffirms and confirms the respect for basic human rights and the right of peoples to self - determination and on the basis of United Nations' resolutions relevant to the Palestinian Question and the Arab region including resolutions 242 and 338, the P.L.O. will participate in the international peace conference in its capacity as the sole legitimate representative of the Palestinian people which is recognized on the Arab and International levels and has an observer membership status in the United Nations Organization since the year 1974.

The Participation of the P.L.O. in the International Conference will be on the basis of safeguarding the legitimate rights of the Palestinian people including their right to self - determination through a confederation with the Hashemite Kingdom of Jordan as stated in the Jordanian - Palestinian Accord signed in February 1985.

In this context the P.L.O. reaffirms its denunciation and rejection of terrorism which it had confirmed in the Cairo Declaration.

Steps

A. To be handed to his Majesty the King.
